The data in the report is based on projects reported on a daily basis in BCI Asia's real-time project lead database. For the previous 2 years, all projects at 'competition', 'concept', 'design', or 'documentation' stage are extracted from the database, quarter by quarter, by publishing date. Only 'new' projects (projects reported for the first time) are included.

The data is analysed and presented by construction category (as in the Forecaster Report) and, where appropriate, by region.

We also report on the key economic indicators and their relation to the construction industry.
